

Based on article 16 and 18 from the Law on Associations and Foundations (Official Gazette of RM no. 52/10), the Assembly of the Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS, on 13.10.2010 has made the following

STATUTE

Of the Association of citizens for people with dysfunctions, handicap, rare diseases and special needs
GIVE US WINGS

1/ Basic provisions

Article 1

The Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS from Skopje is non-government, non-profitable organization, formed by voluntarily associated citizens.

Article 2

The Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS from Skopje will not form a political organization, and will never be a part of political activities and obligations.

Article 3

The Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS is a legal entity with rights, responsibilities and obligations based on the Laws and the Constitution.

Article 4

The Association is called Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS from Skopje, address: Gjorgji Dimitrov no. 13 lamela 2 lokal 10 Skopje.

Article 5

The seal of the Association is round with usual dimensions, with the following text: The Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS. The stamp has rectangular form and contains the name, the archive number and a place for date.

Article 6

The founders decide for the modification of the name and the address of the Association.

2/ AIMS AND TASKS OF THE ASSOCIATION

Article 7

The Association of citizens for people with dysfunctions, handicap, rare diseases and special needs GIVE US WINGS from Skopje is formed to realize its main purpose: to educate regarding the human values, assistance of the people with special need for longer period, creating a reference data base for the people with special needs, introduction of methods and treatment techniques for various physical and mental dysfunctions in the R. of Macedonia.

Other purposes and tasks of the Association are: creating a list of protocol for each disease, syndrome etc., interactive participation of the people who are involved and those who wish to receive information for the problems with which they have to deal, their rights, therapies, world centers, authorities and links with advisors-volunteers, education through seminars, congresses and tribunes, effort for better life quality and modification of the model of communication.

3/RIGHTS AND OBLIGATIONS OF THE MEMBERS OF THE ASSOCIATION

Article 8

The members of the Association are obligated to:

- Participate actively in making decisions and the activities
- Choose and be chosen
- To give suggestions related to work
- Other obligations related to the Statute
- In the Association the right and the responsibilities are equal

4/MEMBERSHIP AND TERMINATION OF MEMBERSHIP

Article 9

Each Macedonian citizen can become a member, no matter what his nationality is. The member has to sign a registration form and to participate in the activities of the Association, to respect and realize the decision of the Association.

Article 10

The membership terminates if the member violates the discipline, disrespects the rules of the Statute and other documents of the Association. The executive authority will determine the termination.

Article 11

Authorities of the Association:

- Assembly
- Executive Authority

5/ASSEMBLY OF THE ASSOCIATION

Article 12

The Assembly is the highest organ of the Association composed by all members. The Assembly chooses a President, vice president, executive authority and Supervisory Authority with mandate of 4 years. The Assembly gathers when needed, at least 1 a year.

Article 13

The Assembly is authorized to:

- Make the Statute, program and other acts
- To adopt annual work report and financial report and to publish it on the web site
- To submit financial report to the authority in the state administration (municipalities)
- To decide for modification of the purpose of the Association

- To adopt final calculation and financial plan
- To decide for foundation and termination of other forms of association
- To accept new members and to terminate the membership of old members
- To choose the authorities of the association
- To terminate the existence of the association with 2/3 of votes
- To decide for other issues not related to the Association
- To perform activities pursuant the Statute and the general acts of the Association
- To decide about the Association and the termination of other forms of Association with other organizations and international organizations whose purposes relate to those of the Association

Article 14

The meeting of the assembly is called by the president of the Assembly, (or if he/she is not able to do this) the vice president or another member of the executive authority. The meeting is held upon suggestion of the executive authority or 1/5 of total number of members of the Association.

If the president of the Assembly does not hold a meeting in period of 14 days from the given suggestion, the meeting is called by the executive authority or the initiators.

The meeting can be held upon proposal by the Supervisory Authority. The Rules of work determine how the meeting will be organized.

Article 15

The Assembly can work if more than half of the members are present. The Assembly decides with majority of votes. The voting is public; each member of the Assembly has a right to vote.

6/Executive authority of the Association

Article 16

The Assembly chooses an Executive authority. The majority of the members are Macedonian citizens and it contains 5 members. The Executive authority is chosen every 4 years. Executive authority chooses a secretary and a commission. The Executive authority decides on the meetings held whenever needed. The decisions are made with majority of votes of the present members. The Executive authority is responsible for its activities before the Assembly. Executive authority starts procedures for responsibility, termination of membership and dismissal of the members of the Association's authorities. The Executive authority dismisses the members of the authorities and a member of the Executive authority dismisses the Assembly.

Article 17

The Executive authority has the following obligations, rights and responsibilities:

- To prepare the meetings of the Assembly
- To prepare the Statute (draft) and other decisions for the Assembly
- To execute the policy of the Association, the conclusions and decision brought by the Assembly
- To form a commission and control the activities
- To manage and be responsible for the administration and the property of the Association
- Other

Article 18

Pursuant the Law on Associations and Foundations, the short name for the Association is GIVE US WINGS.

Article 19

The president of the Assembly represents the Association in the legal matters and before third persons, and gathers and presides with the meeting of the Executive authority and the Assembly. He/she also signs the documents made by the Executive authority and the Assembly and the financial documents of the Assembly.

7/MATERIAL AND FINANCIAL ACTIVITIES

Article 20

The Association provides all material and financial assets for the purposes, activities and tasks through donations, own sources, sponsorship, assets from the Ministry of health, Ministry of Education, Ministry of Culture, Ministry of Environment, Ministry of Agriculture, Ministry of Science and the membership fee.

8/Education

Article 21

The Association will organize seminars, congresses and tribunes with professionals who work with children and adults with special needs in relation to health care, education and providing work for unemployed, disabled (seminars and courses from various areas in order to help people).

The Association will organize workshops to realize its aims.

The Association will organize activities for protection of the rights of these people.

The Association will organize activities in accordance with the purposes and will create possibilities for realization of the aims.

11/PUBLIC WORK OF THE ASSOCIATION

Article 23

The work of the Association is public. The authorities of the Association are obliged to inform completely, truly and in time all the members about the work and the decision. The representatives of the media can be present during the meetings of the Assembly and the Authorities of the Association.

12/TERMINATION OF THE ASSOCIATION

Article 24

The Association terminates with decision by the Assembly and with 2/3 of votes of the members.

The property will be transferred to the founders, humanitarian organization and individuals based on the decision of the Executive Authority.

13/Assets of the Association

The Association GIVE US WINGS can gain income from the profit of trade companies founded with assets of the Association and other sources.

Article 26

The Association can receive assets from the Budget of the R. of Macedonia, the budget of the local self-government and the city of Skopje.

14/TRANSITIONAL AND FINAL PROVISIONS

Article 27

The decision for modification and amendment of this Statute is made by the Assembly of the Association. The Assembly interprets the Statute.

Article 28

This Statute enters into force on the day of its decision and is applied from the day when the Decision by the authority for registration of the Association is received.
